McDonald's Under Consideration for Citrus Circle

In case the rumor-mill hasn't come to your door, McDonald's fast-food establishment is poised to submit an application to convert and expand dramatically the vacant former bank building at the corner of Citrus and Oak Grove to a drive-thru McDonald's restaurant. This was confirmed last week by city officials. The plan document and more artistic renderings of the proposed filing are a matter of public record and can be viewed on the Woodlands website at <http://www.woodlandsassn.org>.

The building has been unoccupied for some time, the last tenant a real-estate firm that lasted only a few years. The leasing agency and city officials have been working to land a tenant that will provide long-term stability, as well as long-term tax revenues from the property, and McDonald's certainly fits the bill.

The Woodlands Board has been in touch with city officials, and they have been very helpful in providing us with timely information. As you can see from this artist rendering, a drive-thru will be part of the proposal. The Board has not taken a position on the proposal, as no formal application has been made to the city as of yet. However, if the application is made as expected, the Board is identifying a list of concerns that include the appropriateness of another fast-food establishment at the entrance to our neighborhood, the effects of additional traffic at an already very busy intersection, the breadth of redevelopment plans, the hours of operation that McDonald's will apply for, and the suitability of a drive-thru operation (the Board's understanding is that Carl's Jr. was denied a permit for a drive-thru).

A city planner will be assigned to the project once an application is submitted. That person, when named, will be available to field questions from the public. In the meantime, we would like to invite public comments on this issue, which we will post on our website and include in the August newsletter. Please send your comments to woodlandsassn@yahoo.com. The Board may suggest a neighborhood meeting so residents can learn more about the current state of the proposal, the effects this establishment may have on our community, and strategies for discussions points to bring to the advocates of the plan. Please check the website frequently for an announcement of the date and time of this possible gathering.




