## A Visit from WC Council Member Kish Rajan

Kish Rajan came to the May Woodlands Board meeting and provided us with an update on issues concerning Walnut Creek. He talked about downtown development as well as development closer to the Woodlands. Specifically he indicated there is no longer an active development for the Safeway property located at the corner of Oak Grove and Ygnacio Valley Rd (most recently a medical office building was under consideration). He indicated the city of Walnut Creek is facing a deficit for the current and next fiscal year and will need to make difficult choices to close these deficits, but he was very optimistic about the future. Several members of the Walnut Creek City Council are hosting community meetings over the next few months to discuss these issues and to obtain community input. 
