On Saturday, October 1st, the City of Walnut Creek launched its first annual Community Service Day. Commencing with a Pancake Breakfast - provided by the Lions Club of Walnut Creek - hundreds of volunteers from Walnut Creek, and surrounding cities, were dispatched across the City to one of 42 different volunteer opportunities. Opportunities that varied from painting the garage at Meals on Wheels to insuring that our trails and parks are clear of garbage.

The successful event drew 993 volunteers to pre-register, including many from the Woodlands community, who gave between four to six hours of their time to complete assigned tasks. Their hard work, dedication, and volunteerism, is yet another reason of what makes this community such a great place to live.
