#### PARCEL TAX TO BE PLACED ON 2008 BALLOT BY MDUSD SCHOOL BOARD

The MDUSD Board of Education voted 5-0 on July 17th to place a school parcel tax before the voters by June 30, 2008. This is the first step towards placing the tax before the voters. The amount of the parcel tax, duration, and what it would cover will be considered once additional information has been gathered by the district.

Our schools are one of the key reasons many of us chose to settle in the Woodlands. As we have all read and heard from friends, neighbors and the press our school district is working hard to provide our teachers equitable pay and benefits appropriate to their roles and in line with the surrounding school districts.

Our Mount Diablo Unified School District (MDUSD) is in negotiations with our teachers for a new and fair contract for the coming school year. In question are salaries and, of course, benefits. The hottest dilemma on the table is that our MDUSD currently only provides paid dental & vision benefits, but no paid medical coverage. Medical is not covered because teachers voted in 2000 to take a pay raise of about \$3,600 in lieu of medical benefits choosing to pay for medical coverage out of their salaries. Since 2000 the cost of family medical coverage has skyrocketed to over \$14,000 per year. So the teachers want to regain full medical benefits and are also negotiating salary increases. However, looking at salaries only, our MDUSD is competitive with surrounding districts that are similarly funded, but not with those districts that have more money that MDUSD.

Exacerbating this situation is the fact that the MDUSD's student population is actually dropping. State funding is based on student enrollment so fewer students mean decreased revenue to the MDUSD. Although it would seem that as student numbers drop costs would drop as well but this is not the case. The loss of one student in each grade at each elementary school would reduce MDUSD's budget by about \$1 million, with no accompanying reduction in the costs (the loss of a single student in one grade does not equal any reduction in teaching staff, other staff, or other costs). Also interestingly, the unrestricted state funds that can be used directly for teachers salary & benefit increases is significantly lower per student than the surrounding school districts.

MDUSD simply does not have enough funding for what our teachers are requesting. It turns out that the surrounding school districts simply have more funding per student. Firstly, as mentioned above, the surrounding districts get more unrestricted funding from the state. Surrounding districts also have parcel taxes in place for the schools. Examples include Moraga where property owners pay two taxes... \$325/year for elementary/middle schools and \$189/year to the Acalanes high school district totaling \$514/year. Another example is the Piedmont School District where property owners pay a \$1,800/year parcel tax for schools. (*continued on page 3*)

Teachers can get similar or higher pay plus regain their medical benefits in surrounding school districts and we have too many cases of quality, experienced teachers leaving our school district for appointments in other districts. Needless to say, maintaining the quality of our schools also helps protect the Woodlands property values.

A parcel tax would bring us closer to a level playing field and reduce the competitive pay/benefits disadvantage in relation to the surrounding school districts. A parcel tax would be used to pay for teacher salaries, special programs, etc. and requires two thirds majority vote to pass. Parcel taxes are assessed as a fixed amount per property parcel. Every property owner pays the same. Contrast this to a school bond issue. School bonds require 55% voter approval to pass and then are assessed to home owners based on the assessed value of your property. School bonds are typically for school buildings and various infrastructure improvements and cannot be used for programs. Of course bond assessments would vary from home to home.

### SIGN-UPS FOR FALL DISASTER TRAINING AVAILABLE Community Emergency Response Training (CERT)

Free CERT classes will start on Wednesday, September 19th through October 24th . These classes are held very close to the Woodlands at the Contra Costa Fire District Training Center located at 2945 Treat Boulevard. Nearly 50 Woodlands households now have been trained. Learn how to help yourself and your neighbors in the event of various disaster types through Community Emergency Response Team training.

The free six-week course includes lessons on suppressing small fires, shutting off utilities, light search and rescue, disaster First Aid, and local CERT team organization and processes.

Graduates are assigned to a CERT Area. Our leader is George Jardim who graduated from the Woodlands training session conducted last year. George's group is called the Valle Verde CERT group. If a disaster strikes, CERT team members are trained to check and assess their own families and homes first, and then assemble at a pre-designated site to work together to respond to the needs of the community.

### **OPEN SPACE OPPORTUNITIES FOR FAMILIES**

We've likely all been to the large wildlife enclosure near the Bayberry Drive entrance to our beautiful Open Space. The enclosure contains a dam and water catch that fills up during the rainy season in December through April. It attracts Mallard Ducks, lots of frogs, occasional Canadian Geese, as well as our local Coyote and the like. You can clearly see the pond coming down Ygnacio Valley Road from Clayton. This enclosure was excavated and enclosed back in 1990 and has been a continuous hit with kids and adults alike. Students from Valle Verde have collected mud samples and tadpoles for science projects here for over 15 years now.

The Walnut Creek Open Space Foundation has come to us for help. The area has become overgrown with non-indigenous plants and weeds, particularly with black mustard, which leaves large dry stalks and makes access to the pond difficult. The protected enclosure is no longer providing the wildlife benefits that it was initially intended to provide... nor is it easy access for our young future scientists.

Removing the black mustard plants, and any other exotic, invasive plants would make an excellent project for some Woodlands families or possibly a local girl scout or boy scout troop. The open space foundation is looking to us for help to take on the challenge to clean it up.

Once cleaned up, we could then plants some riparian species (willows, cottonwoods and similar but indigenous species) in the wetland area, some oaks in the upper banks, and then perhaps some native grasses and wildflowers. The Woodlands Board has met with Bob Simmons, President of the Walnut Creek Open Space Foundation, and he thinks the Foundation can certainly provide real technical assistance and help Woodlands volunteers with the plantings mentioned above. This joint effort can make this valuable resource more accessible to our families and schools once again.
