

### **Safeway Retail Proposal** - Hearing Will be Held August 2, 2011, 7pm By Ed Wohlers

As discussed in the July newsletter (<u>www.woodlandsassn.org</u>), Safeway has submitted an application to the City of Walnut Creek seeking a General Plan Amendment for its 25 acre parcel located on the northwest corner of Ygnacio Valley Road and Oak Grove Road. The application requests the City Council grant authorization for Safeway to study alternative retail/commercial uses on the parcel. If the Council agrees to the study, it by no means grants approval for any type of development.

The proposed project includes relocating the Encina Grande Safeway to a new 55k sq. ft. store that would anchor a retail redevelopment of the Shadelands property, amongst other shopping possibilities. However, the current zoning regulations do not allow retail of this nature and an amendment to the General Plan would be necessary for this to project move forward.

The hearing for the General Plan Amendment request will be held <u>Tuesday, August</u> <u>2, 2011, 7 p.m</u>. in the Council Chamber at City Hall, 1666 North Main Street. # **Consider the Intersection!**

It has been several years since the traffic light at the intersection of Oak Grove Road and Peachwillow Lane was reconfigured. Still, some Woodlands residents seem unaware of courtesies to be extended when approaching the intersection from the east.

When the city of Walnut Creek reconfigured the traffic light, originally there were no lane markings at the intersection. This was confusing, particularly due to left-turn lanes and delayed signal that were created on the opposite (Mitchell Drive) side of the intersection. The city later added "hashed" yellow lines through the intersection to guide traffic. But, the city declined to place hashed lines in the short block between Banyan Lane and Oak Grove Rd.

Many drivers have come to know that there is an "imaginary line" dividing the space between the middle of Peachwillow Ln and the right curb. Some still do not know this and create some angst.

As one approaches the intersection, heading west, imagine that there are two lanes; there is adequate space for such, although unmarked. Consider the "left lane" as the one from which to turn left or to go straight across to Mitchell Dr. Consider the "right lane" as the one from which only to turn right; driving straight across from the "right lane" could be unsafe. Avoid staying in the middle.

It would be helpful for drivers to consider this distinction. Drivers wishing to turn right will appreciate this, especially when traffic is backed up wanting to turn left. Drivers wanting to cross over to Mitchell Dr. from the imaginary left lane will not have to compete with drivers also wanting to cross over to Mitchell from the imaginary right lane.





The parade commenced at Valle Verde and concluded at the Woodlands Cabana Swim Club. Hundreds from the community made their way through the July heat by bicycle, wagon, and foot. Lead by Contra Costa Fire and followed by the Walnut Creek Police Department the event concluded with a BBQ, swimming, and events for children and adults. A great time was had by all.

We thank all the volunteers that made this event happen, especially the Diablo View Rotary of Walnut Creek who without their help and support this year's event would have been canceled.




