Preferred Land Use Plan Proposal

The 7th Advisory Committee Meeting to discuss the Shadelands Gateway Specific Plan, the proposed development at Ygnacio Valley Road and Oak Grove Road on a 25-acre parcel owned by Safeway, was held at Valle Verde Elementary School on the evening of June 27th. The meeting's purpose was to review and discuss the Preferred Use Plan and Development Standards.

The consultants from RRM Design Group presented a Preferred Land Use Plan PowerPoint (see above) that included details on a 'Central Green District,' a minimum of 2 acres of space Preferred Land Use Plan

combining a plaza and green space. The Plan also includes a 'Gateway District' with retail, such as the proposed 55K square foot Safeway store, restaurants, and services. The 'Shadelands Drive District' was shown to possibly include office space, a health club, services, limited ground floor retail, and residential units.

The "Gateway Element" shown above would result in the loss of the protected right turn from Oak Grove Road onto Ygnacio Valley Road. During the public comment portion of the meeting residents voiced concern over the elimination of this lane.

Following the presentation on the three districts were slides illustrating Parkways/Primary Setbacks

This was the first AC Meeting to be held outside of Walnut Creek City Hall, and the turnout was higher than recent AC Meetings. Woodlands residents and a resident who lives on Via Monte near the existing Encina Grande Safeway spoke during the public comment portion of the meeting, when members of the public lined up to share their thoughts on the proposed development with the AC Committee. The primary concerns included traffic and safety issues along already congested Ygnacio Valley Road and the impact on existing backup on Oak Grove Road. Also of concern were the locations of proposed entrances and exits into and out of the shopping center, along Ygnacio Valley Road, Via Monte, Oak Grove Road, and Shadelands Drive.

At the close of the AC Meeting at Valle Verde, Deb Karbo, the applicant from Property Development Center, announced that Safeway would not hold the previously planned July 10th community meeting at the existing office building on the site. The reason for the cancellation was to be able to provide the community with more information at a later time.

The 8th AC Meeting was held Wednesday, July 25th, from 6:30 p.m. to 8:30 p.m. at Civic Arts Education - Dance Studio at 111 N. Wiget Lane. We will provide an overview of that meeting in the September issue of The Woodlands. We will also post news on additional AC Meeting and Safeway community meeting times and locations on The Woodlands website at http://woodlandsassn.org/. 


