

# A Year In Perspective

The Woodlands newsletter has been published continuously for over 40 years and is an important resource for the neighborhood. It is staffed by volunteers in the Woodlands and is supported by the advertising revenue. If you know good vendors and service people, please be sure to mention the newsletter as an advertising esource. It reaches over 900 homes and local businesses each month. Advertising ranges from \$5.00 to

resource. It reaches over 900 homes and local businesses each month. Advertising ranges from \$5.00 to \$80.00 per month depending on the size of their advertising.

You have seen the form and content of the newsletter evolve over the past few years. The most dramatic improvement has been during the past four months where a whole new look and feel has been introduced. Besides focus on content we are attempting to keep costs in line with our advertising revenue which has been close to break even in the past year or so. Please email the board from the website if you find interested advertisers. We need all of them.

During past years and especially during the '05/06 and '06/07 school years, your Woodlands Board has kept a close watch on the activities of the Mount Diablo Unified School District. The Woodlands Board has been present at many district meetings providing timely comments on issues of importance to the Woodlands, such as the permanent inclusion of Crystyl Ranch to Northgate High School, the cancelled high school boundary study, the denial of the Montecito petition to be included within Northgate High School boundaries, our negotiated contribution to the District for funding a second new classroom at Northgate and the like. Through these and similar efforts, the Woodlands Association gained an increased level of recognition by the District School Board. We will continue to monitor District activities in the coming years and represent Woodlands residents on issues regarding school boundaries and improvements.

The Woodlands Association was able to identify and facilitate \$225,000 in improvements to our three public schools. These funds were negotiated from the Citrus Walk development. This funding provided the new technology center network and equipment improvements of \$40,000 to Foothill Middle School in May of 2006. Northgate High School received \$160,000 to complete the funding of two new permanent classrooms in January of 2006. Valle Verde Elementary received \$25,000 in May of 2006 for the new shade structure to be constructed next to their multi-use room.

Every year the Cabana Club goes all out to open their doors for our Woodlands neighbors. The Cabana Club and the Woodlands Association have had a close relationship for over 40 years. From time to time we have common board members and this year is no exception. The Association provides a small amount of funding for the Cabana Club 4<sup>th</sup> of July activities and, as always, provides gratis newsletter advertising as well as maintenance of the Woodlands bulletin board you can see on Citrus.

The Woodlands Association has assisted Boy Scout Troop 832 by "re-chartering" the troop every year for 27 years. The Woodlands Association is the troop's charter sponsor. The troop meets every Tuesday evening at Valle Verde Elementary. You have seen newsletter items from time to time covering both Boy Scouts' and Girl Scouts' activities. In 2006 the Woodlands Association sponsored the Woodlands US Flag Retirement Project and Ceremony as part of Matthew Clark's Eagle Scout civic project requirement. Mathew fulfilled all his requirements and earned his Eagle rank in late November 2006.

hood can cope during and after a major emergency. The city sponsored a Woodlands training session using the national Community Emergence Response Team (CERT) training methodology. More than 50 Woodlands households now have someone trained and certified in this important set of skills. Each of our certified residents attended the 20 hour training course over a six week period. The course was funded for us by a federal Homeland Security grant.

Our new website is now just in its second year of operation. The association summarizes Woodlands "public police log" activity in our newsletter from time to time for neighborhood awareness. Also the board has been involved in several problem fixes... for example... most recently, several neighbors brought concerns to the Woodlands Board over vandalism and damage on and around the barrier wall between Valle Verde Park and Citrus Marketplace. The owners of the barrier wall behind Nob Hill did not seem to react so the board got involved with the most impacted neighbors. After several meetings with the neighbors, the Citrus planning department, the parks department, the city compliance officer along with representation from the Citrus Marketplace owners, the problem seemed to begin to resolve itself. It turned out that the vandalism had been caused by Woodlands youth attempting to maintain a short cut to Citrus Marketplace from Valle Verde. The barrier has been rebuilt and the other stipulations by the city compliance officer are being met by the Citrus Marketplace owners.

Our Woodlands Association has had sufficient newsletter advertising revenue to cover newsletter and other expenses for several years now. Hence the Woodlands board has been able to waive annual dues for quite some time. Fortunately we are still just a bit above break even with revenue over expenses. Now that we have been able to reduce the publishing expense our intent is to keep the advertising revenue high enough to accumulate some surplus for additional Woodlands neighborhood and youth education improvement projects.
