Woodlands Association Has Not Taken a Position on Safeway Proposal

The Woodlands Association would like to thank those neighbors who have taken the time to share their comments and suggestions regarding the proposed Safeway development. We would also like to clarify that the Woodlands Association has not taken a position rejecting or endorsing any proposal or plan for the Safeway property. The June cover article, "A Proposed Shadelands Compromise," was submitted by a concerned Woodlands resident and was not a reflection of the Woodlands Association Board. The Woodlands Association may take a position on a proposal in the future based on hearing from the community and evaluating a more fully developed proposal once it is under consideration by the City.

When Safeway's Property Development Centers asked the Walnut Creek City Council to consider amending the General Plan for the Shadelands Business Park to include mixed use retail, the city responded by setting up an 11-member Advisory Committee (AC). The AC will create a Specific Plan subject to approval and or revision by the various City Commissions and City Council. The City Commissions and Council will also hold public meetings to discuss possible changes to this property after the AC completes its work.

We continue to encourage Woodlands residents to attend these meetings to learn what proposals are being made and to add valuable feedback on how this property could be developed in a way that would add to the quality of our community and not adversely affect current businesses and residents.

Some of the letters the Woodlands Association has received have suggested:

- Development of a large supermarket and gas station
- Reserving a large portion of the property as open space or a community park
- Zoning for Business Park should remain
- Creating entrance on Oak Grove Road would worsen already difficult traffic
- Additional retail development would adversely affect current retail

This is our neighborhood and our community. The City and Safeway developers need to hear our voices on this matter. We encourage all residents to attend public meetings or provide written comments to the City on development of this property.



Shadelands AC Meeting Update: Traffic Study Results

On May 23rd the City of Walnut Creek held the sixth Shadelands Advisory Committee (AC) meeting to discuss possible changes to the 25-acre Safeway owned property located across from the Woodlands neighborhood at the corner of Oak Grove Rd. and Ygnacio Valley Rd (YVR). The meeting's focus was to review a traffic study completed by W-Trans, an external consultant hired by the City.

The consultant reviewed current site traffic flow and conditions throughout the area. The highlight of the evening was the traffic analysis of two intersections: 1) Oak Grove and YVR and 2) Via Monte and YVR. Currently, without any site changes, an average of between 35,000 and 50,000 cars cross the YVR and Oak Grove and Via Monte and YVR intersections throughout the day. On a grading scale of A though F - with F being the worst – these intersections are rated an average of an E.

After presenting the current conditions, the consultant's focus turned to an analysis of traffic patterns on the presented land use possibilities being considered by the AC. The additional traffic generated by development of this site would contribute an additional 16,000 to 18,000 daily additional cars, making the intersection of Oak Grove and YVR the highest traveled and most congested intersection in Walnut Creek.

The next AC meeting will cover an alternative proposal, presented by the AC consultants, representing the best use alternative based on feedback from the AC members. Independent of your feelings about development at this site, it is highly recommended that you attend the meeting and speak up or send your opinion to the Woodlands Association - woodlandsassn@yahoo.com - for possible presentation at the AC meeting. The Woodlands Association has not taken a position regarding the Safeway property and our priority at this point is to keep the community informed.

The June 27, 2012 Advisory Committee will be held at Valle Verde Elementary MUR from 6:30-8:30pm and the July 25, 2012 meeting will be held in the 3rd floor conference room at Walnut Creek City Hall from 6:30pm – 8:30pm. Final Shadelands Property Development Meetings This Month

The last scheduled monthly Advisory Committee (AC) meeting to discuss the possible development of what is now open space at Ygnacio Valley Road and Oak Grove Road, land owned by Safeway, will take place on July 25th in the 3rd floor conference room at Walnut Creek City Hall from 6:30pm – 8:30pm. We will let people know if any additional meetings are scheduled. Many residents from the Northgate and Woodlands neighborhoods have provided feedback during meetings, including concerns about development of this large property located directly across from the Woodlands neighborhood, and you are encouraged to attend the final meeting.

Next, the AC will prepare a Draft Specific Plan for consideration by the City in the near future. The completed Draft Plan will go through the various City Commissions (Design Review, Planning, Transportation) and then to the City Council for feedback and possible changes. While the Commission meetings are taking place, an environmental impact report will be prepared over a 4-6 month timeframe, according to the Planner assigned to this project. Public comment is encouraged at each of these meetings.

In addition to the public AC meetings, Property Development Centers (a Safeway Company) has been hosting community meetings in the existing office building located on the site. The last of these meetings will take place on Tuesday, July 10th, from 6:45-8:30 p.m. All members of the Walnut Creek community are invited to attend. The purpose of the meeting is to update the community on the progress of the AC and to listen to your comments regarding the future development of the site. Property Development Centers will share the feedback from the neighborhood meeting with the Advisory Committee at the ensuing AC meeting.


