# A Proposed Shadelands Compromise

As many of you know, Safeway has requested a rezoning of its property in the Shadelands to build a large shopping center at the northwest corner of Ygnacio Valley Road and Oak Grove Road. Many community members have expressed significant concerns about Safeway's proposal, including increased traffic, vacancies and economic blight at the two existing shopping centers (Citrus Plaza and Encina Grande), aesthetic blight from an inundation of shopping centers in our neighborhood, and problems with adopting a piecemeal approach to development in the Shadelands.

In addition to these concerns, a report prepared for Safeway's proposal raises major doubts as to the economic viability of the 55,000 square foot supermarket Safeway would like to build in the new shopping center.

At the Shadelands Gateway Advisory Committee meeting in April, I introduced a proposal for this property - based on an idea from other concerned community members - that provides a real benefit to our community while accommodating Safeway's objectives. This proposal also offsets the negative consequences of adding another shopping center to our neighborhood.

Under this community proposal, the City would grant Safeway the requested rezoning on their already developed land on the western half of the property – currently occupied by office buildings and parking lots – allowing Safeway to build its supermarket and other appropriate establishments, such as restaurants and additional retail. The eastern half of the property that is currently undeveloped (the grass and tree-filled area directly at the corner of Ygnacio Valley and Oak Grove) would become a community park, the land dedicated to the City by Safeway. This would create a signature property with real benefits to the community.

This community proposal does not eliminate

Accidents can and do happen here. There was a collision on Citrus Avenue last month with enough impact that airbags deployed in both cars. However, this community proposal is a fair outcome to all parties involved, including Safeway. Safeway bought property zoned for a business park, not a shopping center. Yet under this community proposal, Safeway would obtain a free rezoning for half of its property to build its shopping center and approval of its 55,000 SF supermarket, while the community benefits from a new park.






