

PRESIDENT'S MESSAGE

Changes, changes and more changes. The board members met with John Damavandi, owner-developer of Burton Center, and Steve Klee, the property manager. The concern of the Center's management is that some 30,000 square feet remain vacant after four years. Two years ago it was proposed that a Round Table pizza parlor occupy the vacant space but this brought strong opposition from those whose residential property abuts the proposed site and from those who felt that any such establishment would become a hangout for young people.

Mr. Damavandi was invited to communicate with Association members via the newsletter to express his concerns, explain his viewpoint and solicit feedback from the community. If you have an opinion regarding this proposed development, please respond if so asked and make your reaction specific so that potential problem areas can be addressed and, if possible, solved.

Secondly, the Walnut Creek Design Review Commission had approved a proposed two-story, 40,000 square foot, office building at the north-east corner of Oak Grove and Ygnacio Valley Road.

The design was approved unanimously, which is quite unusual. A public hearing on the design will be held in the City Council Chamber, 1666 North Main at 7:30 PM on March 16th. Alan Grant (943-5830) is the City's project planner and the design and plans, may be obtained from the architect, Jerry Loving (944-1626).

Last Week the Directors of your Association met with the Owners and Manager of the Burton Village Center and Cy Potts, President of the Burton Village Merchant's Association to review the prospects for leasing the remaining 15,000 square feet of vacant space at the center and to discuss some of the prospective uses that have presented themselves. All present were happy to note the success, cleanliness and quality of service of operation of the new King Tsin Restaurant, which opened it's doors in September 1982. The Grand Opening included special ceremonies and entertainment at which Mayor Margaret Kovar, Members of the Council and other civic business leaders were in attendance.

Representing the Merchant's Association, local resident, Cy Potts, recently opened the 4,000 square foot "Cybet Computers" store. Potts pointed out to the Directors that a healthy shopping center is a full shopping center and that a healthy shopping center is a decided asset to adjoining residential neighborhoods. Directors and others alike agreed that the poor economy and business climate of the past two years had shown it's effect in the exceptionally slow lease-up of the center. Mr. Damavandi, the owner pointed out that clearly the so called "Boutique Character" promised for the center by the Burton family ten years ago was simply not a realistic expectation and that the Shadelands Office Park and Woodlands residential neighborhood had already demonstrated their purchase power preference for service and food related shops.

As an aside it was noted that "Al's Market" had just come under new ownership of new Woodlands resident, Pete Maiorana and family who will be providing full service meat, and fresh fish market operations in addition to the delicatessen services.

Damavandi queried the Directors about a new consideration by the homeowners of a proposed Pizza Shoppe or alternatively an Italian Restaurant. Although generally very favorable toward a new restaurant, the Directors' reaction to a new Pizza Shoppe was mixed and it was suggested by them that a sampling of opinion of the general membership, much like that of two years ago, be undertaken.
