
# To Jim Tilley - With Thanks and Appreciation



# **Parcel Tax Meetings**

As many of you are aware, the Mt. Diablo School Board voted on June 19<sup>th</sup> to pursue a parcel tax in the spring/summer of 2008. The group that is supporting the parcel tax has selected a name, a Treasurer and has filed for campaign committee status with the state. The name is the **Community United for Excellent Schools.** 

The next meeting of the committee is Thursday, October 11 at the Dent Center at the MDUSD headquarters located at 1936 Carlotta Dr. in Concord. Meeting is at 7:00pm. The committee is hoping that there will be representatives from all schools as well as community members present.

President Eberhart also appointed a Board Committee to Support the Parcel Tax. Linda Mayo and Paul Strange were appointed as Committee members.

The Board also voted to hold additional community meetings on October 2<sup>nd</sup> and 16<sup>th</sup>. On October 2<sup>nd</sup>, there will be two simultaneous meetings at 7:00 pm at Concord High School and Foothill Middle School. On October 16<sup>th</sup>, there will be two simultaneous meetings at 7:00 pm at Riverview Middle School and College Park High School.

Once the District has completed the community meetings, the Board will be making decisions regarding the amount of the tax, the uses it will be put to and what exemptions will be included. The Board is planning to make these decisions in November.

Many believe that this parcel tax effort is crucial for our district. MDUSD unrestricted revenue per student is the lowest in Contra Costa County and 150<sup>th</sup> out of 160 in the Bay Area. If you are interested, please attend one of the community meetings on October 2<sup>nd</sup> or 16<sup>th</sup>.
