

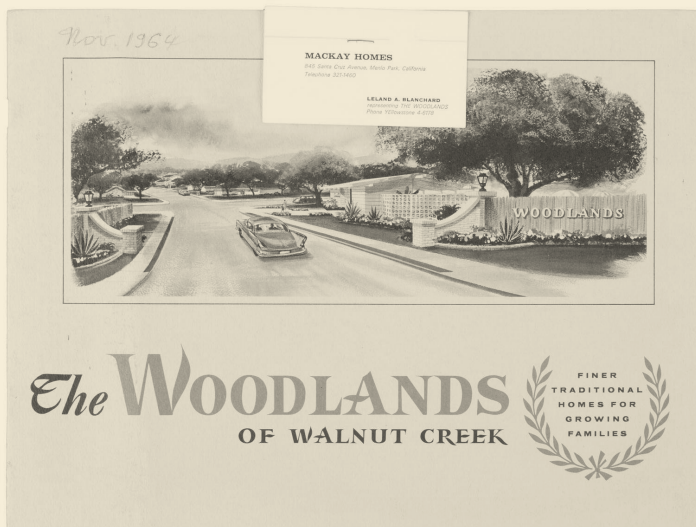

I saw an article this month in the New York Times about the final edition of the Warroad Pioneer, a newspaper in Warroad Minnesota that closed its doors in May after serving a community of just under 1,800 residents for over 120 years. I found it to be a poignant article, in part due to its characterization of the void the paper's absence will leave in this small community, but also because it struck so close to home in run up to this, our final edition of the Woodlands Newsletter. While there are many differences between the fate of the Pioneer and this publication, the impact, and loss, are similar in many ways.

The Pioneer will no longer print “soft-focus features on residents, reprinted news releases, photos of fishermen with their outsize catches, and news of awards won by children and Shriners.” Or “the occasional stories, too, about city officials, the school board and local sports”. The Woodlands Association will no longer recap the Fourth of July parade or the light displays around the holidays. We’re also losing our best platform to share information about more weighty issues of interest to the neighborhood, including ‘hyper-local’ coverage of changes in the local shopping centers, who’s running for City Council, and proposed new housing.

This is a loss that may not be felt by all, and probably not by any all of the time. We’ve had plenty of ‘slow news weeks’ in the six plus years I’ve been on the Board, and those of us producing this newsletter have certainly thrown in some ‘filler’ from time to time. There have been many subjects, however, that only we could cover in a way that’s useful to this neighborhood. In just the last few years we have devoted significant coverage to a proposed new local school district, speeding on our streets and the Orchards Development as it wound its way through the city’s approval process. Now subjects like these will either not be covered at all or will be covered at a much higher level by regional papers like the East Bay Times. Now residents will need to comb through the conversation threads on services like NextDoor and try to separate the wheat from the chaff and attempt to distill the information that is useful from the chatter that is at best idle and at worst misleading.

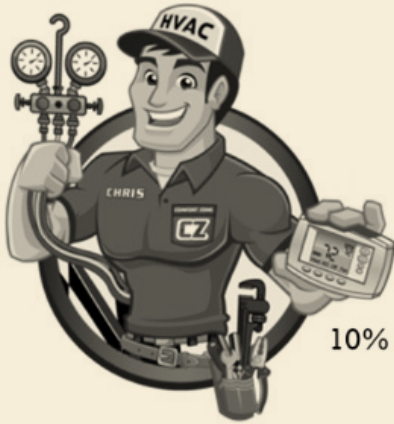
